

GENERAL INFORMATION AND TERMS OF AGREEMENT

WESTERN IRELAND PHOTO TOUR - With Richard Martin and Charlene Kenna June 12th to June 22nd 2010 (10 nights)

Acceptance

PHOTOGRAPHIC EDITIONS will acknowledge your acceptance and reserve your place on the WESTERN IRELAND PHOTO TOUR upon receipt of your application and deposit on a first come basis. Upon enrolment you will receive an email to acknowledge receipt of payment and a bill for the balance due. Further information about the tour will be mailed out to you one month before departure.

A deposit is required now, to confirm your space on the tour, without this, we will be unable to process your application. The deposit of \$1730.00 CAD or the full amount of \$3460.00 CAD can be paid by Canadian cheque payable to PHOTOGRAPHIC EDITIONS. Alternatively a bank money transfer or credit card on Paypal (please enquire by email – there is additional 2.9% Paypal commission). Mail the completed application form, initialled on each page, including deposit if paying by cheque, to the address on the last page. If you would like to pay in U.S dollars, please contact us at time of payment to inquire about the exact amount and please make sure that the cheque says “U.S funds”.

Payment of Balance and Fees

A 50% deposit is required at the time of booking. This deposit secures a place on the WESTERN IRELAND PHOTO TOUR. The balance of your tour fee is due no later than April 14th 2010. If the total balance is not received 60 days before tour start, we reserve the right to treat this reservation as cancelled and charge the cancellation fee. Tour fees cover all surface travel from the meeting and departure points at the Shannon Airport, photographic instruction with Richard Martin, accommodations based on double occupancy and breakfast each day. Not included are airfares, transfers to and from the airports, meals where not stated, travel insurance and other incidentals not listed above.

Cancellation

Cancellations received 60 days or more prior to departure will be subject to an \$800 per person cancellation fee, 59-31 days, \$1730.00 per person; within 30 days, 100% of tour cost. If at the time of your cancellation, we have a waiting list and are able to make a confirmed booking, the cancellation fee will be \$350 to cover administration costs. We will endeavour do our best to fill your spot.

PHOTOGRAPHIC EDITIONS reserves the right to cancel this tour prior to the departure date for any reason including that of insufficient enrolment. Alternatively, PHOTOGRAPHIC EDITIONS may offer to operate a smaller tour if all customers agree to a supplemental charge due to the low number of tour members (5 people or less). If customers do not accept to pay the supplement, PHOTOGRAPHIC EDITIONS will refund their payment in full, which will constitute the full settlement. PHOTOGRAPHIC EDITIONS reserves the right to alter the time, context, or format of this tour in the event circumstances so require. If it is necessary to cancel this tour, all registered customers will be informed immediately, and will receive a full refund of all deposits and fees. Notification of cancellation will be made at least fourteen days prior to the departure date. In the event that the tour is cancelled, PHOTOGRAPHIC EDITIONS is not responsible for refunding costs incurred by the customer including but not limited to non-refundable airfare or any costs separate from the tour fee. For this reason PHOTOGRAPHIC EDITIONS encourages all participants to purchase refundable airline tickets and trip cancellation insurance or to purchase their tickets ONLY after they have received confirmation from PHOTOGRAPHIC EDITIONS that the tour has sufficient enrolment to run. PHOTOGRAPHIC EDITIONS is not required to make refunds once tour-travel package commences regardless of the reason for the customer being unable to complete his or her tour.

Important Note

Our days are full and many days will begin early and may involve a moderate amount of walking. All participants are required to be in general good health. It is the responsibility of each participant to properly inform PHOTOGRAPHIC EDITIONS of any medical problems or dietary restrictions. PHOTOGRAPHIC EDITIONS may not be able to cater to special dietary restrictions and we suggest you bring any necessary food and supplements that may be hard to find in Ireland. Please discuss your needs before enrolling. PHOTOGRAPHIC EDITIONS assumes no responsibility for providing medical or dietary expertise to tour participants.

Waiver of Liability

PHOTOGRAPHIC EDITIONS, their agents, servants, employees, contractors, past, present and future shall have no responsibility or liability for personal injury to any participant or damage to any participant's property, or for personal injuries or damage to the property of any other person resulting from the participant's involvement in WESTERN IRELAND PHOTO TOUR. PHOTOGRAPHIC EDITIONS shall have no responsibility for the acts, errors or omissions of instructors or staff, transportation companies, lodging facilities, restaurants, tour guides, contractors and outfitters, or other providers of services to participants in the course of the tour.
